Information we may collect from you

We may collect and process the following data about you:

- Information that you provide by filling in forms on Our website – www.zyc.co.za. IP addresses and cookies

We may collect information about your computer, including where available your IP address, operating system and browser type, for system administration and to report aggregate information to our advertisers and business partners.
